No kind of fancy software or hardware solution is going to solve the problem for you under these conditions.

Unfortunately, parents who are not very computer-savvy are at a great disadvantage, because their kids will always be one giant step ahead of them unless they use good old-fashioned parenting techniques to set rules and help their kids recognize the dangers of the Internet.
