Commissioner Ken Christiansen asked Public Health Administrator Lisa Molstad whether she was aware of the county policy that capital expenditures over \$350 require commission approval.

'Yes," Molstad said.

At issue is Molstad used \$500 of her personal money to apply to a county credit card so Viviana Gariby, receptionist and medical records clerk, could attend training in Great Bend in mid-February.

At the time Gariby attended training, the credit card in question had \$199 available credit, according to paperwork Molstad presented the commissioners The account has a \$2,000 credit limit, but was carrying a balance of \$1,800.08.

When an attempt was made to apply Gariby's meals and lodging to the card, the transaction was declined. Molstad made a \$500 payment out of her personal banking account over the phone to make the transaction go through.

Molstad asked the commissioners to reimburse her for the \$500, which prompted Christainsen to ask Molstad if she knew about the policy pertaining to her actions.

Molstad also asked the commissioners for permission to fill a vacancy at the public health department created by the resignation of Kathy Ryan.

Ryan resigned 10 days after commissioners gave Connie Walden, a registered nurse at the public health department, a 48cent per hour raise. The increase made Walden's pay equal to Ryan's at \$20.36 per hour.

Ryan, in a letter to Molstad dated Feb. 20, stated she was deeply hurt and could "no longer trust

Molstad shared with the commissioners a memo she sent Ryan stating she would offer her a 20-hour work week with flexible hours for a trial period of six months. However, Molstad said Ryan plans to follow through with her resignation effective April 1. Ryan has worked for the Thomas County Public Health Department for more than 27 years.

The commissioners asked Molstad to report to them in March whether Ryan's vacancy creates a burden for the department. Steele asked Molstad to be sure and track how many hours nurses spend with patients.

Molstad wanted the commissioners to clarify the term "contact hours" so she knows what to report. Steele said the term means time spent with patients which can be billed to either the patient or an insurance provider.
