# State promises Oberlin airport \$1 million

State officials promised the City of Oberlin \$1 million in a matching grant from the Kansas Department of Transportation for a longer runway at the airport here, a project a group of area representatives have been working on.

County Commissioner Doyle Brown said he went to Topeka with City Councilman Jay Anderson and his wife Ann; Doc Franklin, with the Decatur Tomorrow planning group; City Administrator Gary Shike; Councilwoman Rhonda May; Connie Grafel, marketing manager for the Oberlin-Decatur County Economic Development Corp.; and Mayor Joe Stanley on Tuesday, Feb. 26, for a meeting of the Kansas Airport Association. While in Topeka, the Oberlin group sponsored a dinner with legislators from the western part of the state to talk about the

Mr. Shike said the \$1 million will be put toward the new runway in the first part of a three-phase plan. The total cost for the first phase is estimated at \$7 million, your project is not in a position to he said, including land acquisition, utilize the funds in the fiscal year paving a 5,200-foot runway and a 2009. The city got a request for a 7,000-foot runway from Bus and Coach International out of Jennings. Since then, a committee of council members, county commissioners, economic development representatives and others have worked on the project, lobbying with state and federal officials and applying for grants.

Besides this grant, said Mr. Shike, the city has applied for \$753,000 from the Federal Aviation Administration, but hasn't heard anything back yet.

Some of the project will have to be paid for by the city, said Mr. Shike. He said he isn't sure when the project will get started. It depends on the money, he said, but it could be as soon as 2010.

The letter from the Transportation Department says the money will come from the Kansas Airport Improvement Program whenever the city is ready to build a

"While the request scored within the range of projects eligible to receive funding, we are aware that egory, you will not be required to compete in future years. Your project will be at the top of the list in all future years; however, we will not fund the project until you demonstrate that you will utilize the funding in the next fiscal

The letter goes on to say that as long as the airport improvement program continues, the city will receive the money when it is

The city also received a letter about a \$90,000 grant from the department for an automated weather observation system for the airport. Mr. Shike said the city did receive word a few years ago that it had received money for this system, but didn't buy it.

With the weather system, which will help know what the weather is for planes, the city will pay 10 percent. Mr. Shike said most of the systems cost around \$90,000.

Ed Young, chief of the airport program with the state department, said Mr. Shike had talked to him about the grant while the group was in Topeka, but nothing was official until the city got the

Mr. Shike said he is excited feeling positive about it.

Mr. Brown said several legislators encouraged the group to come talk to them anytime, even if they weren't the representatives for this area. He said they also encouraged them to talk to members from eastern Kansas, so that they know what's going on, and maybe support the project, too.

It was a nice delegation, said Mr. Shike, and the dinner went well. There were some heavy hitters there and this gave people from Oberlin and Decatur County some one-on-one time with them.

Councilwoman Rhonda May said she was a little hesitant at first about the dinner because of the cost, but it worked out well and didn't cost as much as she thought. Mr. Shike said he thought the economic development group would pick up the tab.

The group agreed that Mayor Joe Stanley did a good job giving a little speech about what the city is trying to accomplish with the

Doing a dinner like that once a year, said Ms. May, probably wouldn't be a bad idea. It got the group some face time.

"Anyway," she said, "we came home with \$1 million and I think that's pretty good stuff."

## **Farmers** in doubt

TRIBUNE (AP) — Farmers here still don't know if they'll see any payments from their extraordinary wheat crop and fall harvest after a bank foreclosed on the now defunct Sunbelt Grain.

Whether it was a volatile wheat market or something else that caused Sunbelt's demise, the legal battle continues for 33 farmers around this far west-central Kansas town who sold their 2007 crop at one of Sunbelt Grain's four locations in Greeley and Wallace counties. The elevator owes them approximately \$2 million in checks that farmers had deferred until 2008, said Terry Criss, a Salina attorney appointed by the Kansas Department of Agriculture as the receiver for the grain inven-

Meanwhile, it looks as if involuntary Chapter 7 bankruptcy an unusual bid to recover their money will proceed in court.

Security State Bank of Scott City foreclosed on Sunbelt Grain, a limited liability corporation owned by James and Kathy Shafer, on Dec. 14 - tying up millions of dollars in grain.
