Commitments force Titans coach to step down

Brewster superintendent Sherri Edmundson said Tuesday she was unaware of Sheets' intentions not to return.

When contacted by phone Wednesday, Brewster athletic director Laura Rush also said she had heard nothing from Sheets about a decision either way.

It was the uncertainty surrounding Sheets and his staff's future, along with the inability to contact them, which prompted both the Brewster and Winona school boards to begin the search for a new football coaching staff at the high school and middle school levels. Both boards voted to do so April 14.

"We weren't sure that Beau wanted it," said Edmundson. "He told our athletic director he wasn't sure. Other than that, there hadn't been any communication. Mr. (Dave) Porter (Winona's superintendent) tried calling, and he didn't return his calls. To save time, we opened it back up. If he didn't want it, we would already have applications instead of wait-

ing another month. We weren't trying to push anyone out. We just wanted to get things done in a timely manner."

Edmundson said there has also been "no communication" with Sheets' assistant, Jesse Vincent, in months.

Porter said he tried calling Sheets twice this semester at Colby High School, where he teaches math, but neither phone call was

"I left two voice mails at the school, and he never got back to me," said Porter. "I did not know exactly what that indicated."

Sheets admitted Monday to "leaving the situation up in the air" and that was the reason why the board opened up the search. Uncertainty aside, though, Ed-

mundson hinted that not every-

one would have been satisfied if

Sheets did return. "Overall, there were some concerns," said Edmundson.

When asked whether Sheets would get his job back if were he to change his mind, Edmundson said, "I can't guarantee he would or wouldn't be a possibility."

Edmundson wouldn't elaborate further on what the extent of those concerns were. Neither would Porter, who refused comment on

Porter, however, did admit to their being some difficulties with Sheets working for two different

"Any time you're in a cooperative agreement with someone, there's always challenges you have to face," said Porter. "But if our coach lived in Winona or Brewster, that would also present a challenge."

Sheets compiled a 22-16 record and made the playoffs three times in his four years at Triplains-Brewster. The team finished 7-3 the last two years, but lost in the first round of the playoffs to Victoria both times. His teams were known for run-

ning a spread, pass-first offense; a rare thing in eight-man football where the running game traditionally dominates.

"I enjoyed coaching all of the boys," said Sheets. "I got close with most of them. We ran into some tough teams in the playoffs,

but I think it was definitely successful.'

Sheets' younger brother, Tad, will be a junior for the Titans next year. Sheets said he still plans on going to Triplains-Brewster games to watch him play.

Only this year, Sheets will be watching his brother from the stands.

With the Sheets era at Triplains-Brewster now complete, the Brewster and Winona school boards are in the process of looking for his replacement. Edmundson said they've had a "couple of applications" to this point.

"We hope to have someone hired by the May board meetings," said Edmundson. "Hopefully, we can get someone to fill a teaching position too, but that doesn't always happen.'

Brewster's May board meeting is the 12th, while Winona's is scheduled for May 19.

Edmundson said each board will work in conjunction to replace Sheets, his two assistant coaches and the middle school football coaches in Winona and Brewster.


A significant amount of dirt work and freezing temperatures during winter delayed construction of the new \$4.5 million dollar dormitory.
