Refinishing tips offered

Dear Debbie: I have a bentwood rocker that is pretty beat up, and I'd like to refinish it in white to fit in with my bedroom. The seat and back are rattan, and I don't know if the paint will chip off. Is there a special paint or procedure? -Leslie

Dear Leslie: Follow the same preparation for both pre-painted surfaces and the rattan back and seat, which most likely have a sealer finish. Before painting, sand the wood and rattan lightly to rough up the surface so that paint will adhere. If you have sanded down to raw wood (on the frame or rattan), then apply a wood primer to seal the wood before you paint. The easiest way to paint rattan is with spray.


