# Having a ball in Wichita

Colby High senior Josh Baden was already in the discussion of being one of the best distance runners in school history.

After his performance at last weekend's state track meet at Cessna Stadium in Wichita, he may now be at the top of that list.

Baden placed in the top three in all three of his events, including a second-place finish in the 3200 meter run and a pair of third-place finishes in the 1600 meter and 800 meter runs.

Since assistant coach Dee Hovda started at the high school in 1972, she says Baden is the first Colby athlete she can remember placing that high in all three distance events.

"I'm excited about leaving my mark at Colby High School as a distance runner," said Baden. "It's cool to medal in all three my senior year."

Baden, a KU signee, was expected to place in both the mile and two-mile, but his third place finish in the 800 meter run came out of nowhere. Baden came into the race ranked 14th.

"The 800 was probably my favorite race," said Baden. "After the first lap, I was ahead of maybe two or three kids out of 16. On the last lap, I started to pick it up, and the last 200 meters I was up toward the front and managed to stay ahead of fourth. I didn't know if I could run as fast as I did."

Baden's time of 2:00.1 was his best all year. Dillon Cowing of Clay Center won the race with a time of 1:58.12, and Tonganoxie freshman Jeremy Carlisle finished second in 1:58.60.

While Baden played catch-up to get third in the 800, he led for half of the race during the mile before being passed by James Wilson of Abilene and Tom O'Connell of Andover.

Wilson, who also edged out Baden at regionals in Colby May 16, finished first with a time of 4:25.40. O'Connell finished second in 4:27.79.

Baden's third-place time of 4:28.70 was his best all season by close to six seconds, but not quite good enough.

However, he was able to outsprint El Dorado's Andrew Wagner at the end to finish in the third

"I was pretty happy with it," said Baden.

Baden also led for the first part of the race in the two-mile only to have O'Connell pass him once again. Baden ended up seven seconds behind O'Connell for first with a time of 9:46.54—his best all year by 13 seconds, but a second slower than his time last year at state.


things different and won the twomile for sure," said Baden. "I wasn't running quite as well as I would have liked. Since the KU Relays, I haven't been training as well, and I haven't had as good of times as I would have liked."

Though he fell short of the gold, Baden concluded his Colby High career with five top six finishes at state track. His three this year earned all 20 of Colby's team points, vaulting them into a tie for 10th place with Chanute.

"I was really excited about it," said Baden. "I looked on the internet to see how we did as a team, and I had gotten 20 points. I thought that was really cool."

the boys side was the 4 x 800 relay team of Breck Arnberger, Kalen Rasmussen, Ryan Baalman and Chase Moore. They finished 11th out of 16 with a time of 8:37.18. Their time at state was four seconds shy of their personal best time of 8:33 they had at region-

For the girls, April Gee medaled for the second-straight year finishing fifth in the triple jump with a leap of 35-7.5.

In her first state meet appearance, freshman Katrina Kaus finished 10th in the 3200 meter race with a time of 12:27.05, which was also her best of the season. She came in ranked 10th and said she was pleased with how things

"I was happy with it just being a freshman," said Kaus. "It's a lot tougher than around here. I only ran against one girl that beat me all year."

Junior Tate Bruggeman had a career-best third place finish in the high jump to the lead contingent of six Bulldog athletes in Wichita.

Bruggeman, who leaped 6-2, improved upon his fourth place finish last year and fifth place showing as a freshman, scoring all six of Golden Plains' points as they finished 31st as a team.
