Cruise to the Past is open to street rods, classics, customs, muscle cars, special interest and open class. Colby's Cruise to the Past had been a tradition, until the show was not held in 2006. The show was brought back to life last

Tomato concerns prompt caution

Grocery stores and fast-food restaurants are pulling tomatoes and sandwiches off shelves in the wake of a salmonella outbreak in produces flu-like symptoms such the United States.

the safety of our customers, Dillons stores have removed several varieties of tomatoes from sale in all stores due to concerns about potential salmonella contamination based on guidance from the Food and Drug Administration," said Sheila Lowrie, communications coordinator for Dillons.

The U.S. Food and Drug Administration warned consumers about a nationwide salmonella outbreak linked to consumption of certain red, raw tomatoes, particularly red Roma, red plum and red round to-

Lowrie said the types of tomatoes pulled from shelves include raw red tomatoes, such as salsa or salads prepared fresh from delis, salad-bar items, sandwiches and

A spokesman for Wal-Mart said their customers' health prompted pulling tomatoes from shelves.

"Food safety is a top priority at Wal-Mart," said Deisha Galbreth from her office in Bartlesville, Okla.

Local fast-food businesses are following grocery store actions.

'Yes, we pulled tomatoes on May 31," said Shannon Martin, manager of Colby's Sonic Drive-In. Martin said corporate officials with Sonic Drive-In told managers across the country that until the U.S. Department of Agriculture clears all tomato producers, menu items will be void of tomatoes.

Colby's McDonalds restaurant has also pulled sliced tomatoes from its products. Deana Rupp, ue working with governmental and marketing director in Hays for the Subway, is saying the same thing

"Pulling the tomatoes has nothing to do with the McDonalds corporation and there have been no incidents with McDonalds," Rupp said. "We are acting with an over abundance of caution based on the federal government recommendation and we are suspending sliced tomatoes until we get more clarification from the Food and Drug Administration."

Jeff Krzycki, manager of Colby's Taco Johns, is also responding to corporate directions to pull tomatoes from the menu.

'We have received newsletters and telephone calls," Krzycki said. "All Taco John's have pulled tomatoes, and they'll stay pulled until we find out whether (salmonella) is confined to Texas or what the source is.'

Federal mandates could result in higher costs at county jail

Federal mandates may change policies, procedures and costs involved in operating the county jail in Thomas County.

Sheriff Mike Baughn on Monday told Thomas County Commissioners Ken Christiansen and Paul Steele the Prison Rape Elimination Act of 2003 is expected to force changes in the near future in how he operates the jail.

"If the federal government implements the act, it's going to involve personnel and infrastructure of the jail," Baughn said. "While the act was passed in 2003, implementation is not in place yet, but I

expect it in the next one or two years."

The Prison Rape Elimination Act requires correctional and law enforcement agencies to take a zero-tolerance stance toward sexual abuse of people in confinement. The act requires national standards be put in place in all facilities, prisons and jails to eliminate sexual abuse of inmates. The standards and compliance are mandatory, but no deadline has been estab-

"For small agencies," Baughn said. "I think it's preposterous. For prisons it's OK, but for jails it's over-kill.

Baughn said while the Thomas County Jail already has round-the-clock video monitoring of inmates, new laws will require more advanced technology.

"We'll have to have a higher level of on the situation. monitoring," he said. "And we'll have to have something with video playback."

Baughn said the law enforcement center which houses the jail, 225 N. Court in Colby, will require changes.

"We'll have to have a different cell system such as separate cells for those who commit felonies and those who commit misdemeanors," Baughn said. "It would be over- burdening to get the type of cells (the federal government) wants.'

Baughn said he hopes public outcry reaches the ears of federal officials to make the law more realistic. In the meantime, Baughn told tcommissioners he plans to talk with officials from surrounding counties to determine their position increase he is asking for.

"I think I'll meet with the area counties central to Thomas County," Baughn said.

Steele asked Baughn to speak with sheriffs from Cheyenne, Rawlins, Sherman, Wallace, Logan, Decatur, Sheridan and Gove counties about the possibility of forming an inter-local agreement for a regional jail facility.

Baughn said the new law burdens taxpayers even more than they are now.

"It looks not rosy for things," Baughn said. "The taxpayers are burdened to death." While at the meeting, Baughn submitted his 2009 budget request for his office. He said fuel and ammunition costs were a significant portion of the \$36,025

"Ammunition costs are up 40 percent," Baughn said.

Asking for \$198,700 to run his office, Baughn said outside changes the Prison Rape Elimination Act of 2003 may make should it be implemented in 2009, he built in an increase of \$36,025 over what was budgeted for 2008. Of that figure, three big ticket items were fuel at \$25,000, medical care for prisoners at \$16,700 and meals for prisoners at \$16,000.

Separating out what it costs to operate the jail itself, Baughn budgeted a \$3,300 increase for 2009. In 2008, the county appropriation for the jail was \$73,450.

Salaries for the sheriff and deputies will be set when salaries of other county employees are set in January.
