Area students graduate from Kansas University

More than 4,450 students graduated from the University of Kansas this spring — representing 95 Kansas counties, 48 other states and the District of Columbia and 44 other countries, said Mary Jane Dunlap, university relations.

KU's Class of 2008 numbered more than 7,000, including 2,555 who completed degree work in summer and fall 2007.

"Because KU conducts only one formal commencement ceremony each year, many of these graduates returned in mid-May for the university's 136th commencement procession into Memorial Stadium. More than 4,000 members of the Class of 2008 participated," she said.

"Of the 105 Kansas counties, the 10 counties not represented were Chautauqua, Cheyenne, Clark, Hodgeman, Logan, Morton, Norton, Rush, Wallace or Wichita counties," Dunlap said.
