## One and done

#### College athletic director turns in resignation letter

Colby Community College athletic director Duane Arntt said his impendent resignation was a "possibility" on June 30.

Wednesday, that possibility turned into a reality.

After just over a year in Colby, Arntt turned in his letter of resignation to college president Lynn Kreider and will take on an elementary school principal post in the Silver Lake school district in Nebraska. Arntt was an elementary school principal for eight years prior to his time at the college.

"I had a really good job opportunity come up that I couldn't turn down," said Arntt. "I wasn't looking to change. It's something that kinda dropped in my lap. I like working with kids, and that's what I miss most. With this job, you have a lot of administrative work and don't get to deal with kids a whole lot.'

Also factoring into Arntt's decision was the opportunity to move closer to family and secure an early retirement plan. By making the move, Arntt says he is eligible for early retirement in 10 years.

"I really put a lot of thought into it," he said. "Did I come into this job thinking I was only going to stay a year? No. Had this opportunity not popped up, I'd still be here. Although Arntt was rumored on KGCR radio to have resigned early last week, he said the move didn't become a certainty until Tuesday when the school board in Nebraska approved his hiring.

He informed the college of his decision the next day.

"Dr. Kreider was kind of disappointed, but he understood the reasons why," said Arntt. "He hated to see me go.'

Kreider was out of the office late Thursday afternoon and Friday morning and could not be reached for comment. A handful of coaches at the college were in their office Thursday, including new women's basketball coach DeJeanette Flournoy, who was hired by Arntt in April. Flournoy had just returned to Colby from a three-and-a-half week recruiting trip and was floored by the news.

"Wow," Flournoy said. "I mean wow. To hear that, it kinda saddens me because I made a connection with him. He gave me an opportunity to do what I love. He was really open to letting me run the program and get it where I wanted. So, wow."

Flournoy was one of two new coaches Arntt brought in this past year. The other was head volleyball coach Valerie Armstrong. Now, both will have to sell themselves to a new boss right away.

"It's going to be kind of difficult because I got used to Duane and his style, but it's a challenge I'm looking forward to," said Flournoy. "My objectives don't change. I'm all about winning in the classroom, in the community and winning on the floor. I think any AD who comes in will definitely understand and feel my sincerity when I say that. It makes me curious if they are going to bring in someone similar to him or just totally different."

On the other side of the specbreaking for Trojan head wrestling coach Steve Lampe, who will be entering his 33rd year at the college. Lampe admitted to having doubts about Arntt's commitment to the college from the outset.

### Medical student learns from hands-on experience

Kellie Wark, 25, born and raised in Colby, is getting a unique perspective on what a family practitioner does on a daily basis.

For the past six weeks, Wark, a medical student at Kansas University, has been working alongside Dr. Victor Hildyard at Colby Medical and Surgical Center as part of a primary care research program.

'This is totally different than the classroom," she said. "In school, we learn chemicals and in a clinical setting it's more details about the disorders and diseases."
