OK: I did not know him that well with the death. anyway; she was old and had a full life; he was mean to me last year at school, so what do I care? All these messages are meant to save the teen from frightening feelings, and might spark a helpful conversation about how scary death is to everyone.

6. **True**. It could be considered "normal" to want to self-medicate in order to forget or cover up the terrible feelings left when a friend or relative has died. However, such behavior can be self-destructive and offers no long-term help for the grieving teenager. There are experience with death. more productive ways of dealing

7. True. Besides drug or alcohol use, warning signs of a possible dangerous depression caused by the death of someone close include: isolating himself; talking of joining the dead person; loss of appetite or inability to sleep or eat for more than a few days; fear of being alone; withdrawing from friends or normal activities; and excessive anger and irritability. 7. While there is no deadline for mourning to end, a teen should be expected to start moving on within a few months of the death, and there are definite warning signs that help is needed if he seems stuck in grieving mode. True () False () Answers

1. False. Not necessarily. Your teen or college student may be all grown up, but as with any other near-adult, it will be hard to predict the effect of a death on an individual, or how he will outwardly react. The behavior could take any form, from hysterics to denial, and all would be considered a "normal" response.

2. False. Our funeral rituals might be considered morbid, if you look at them objectively, and it would be easier to attend just a service with nothing but photos of the loved one. But if the child wants to attend the service, you can let her go. She may find religious comfort in the words of the officiants. She doesn't have to view the body if she doesn't feel up to it. The reason we have such rituals is to give formal, emotionally survivable organization to these terrible events so that they can be acceptable to our psyche. A funeral provides the opportunity to say a final goodbye, and to share the pain with others.

3. True. As uncomfortable as it may feel to an adult, it's not unusual for a teen to feel closer to a to satisfy the judgment in the abovepet that he has lived with his entire life than to a distant aunt whom he sees once a year. The pet may be his best friend. Parents would be wise to acknowledge the depth of the teen's feelings for the pet and not berate him for seeming not to care about the distant relative.

4. False. Knowing what to say is secondary to allowing the teen to express her shock, outrage, sadness, loss or other feelings and needs. Instead of worrying about what to say, think about listening and encouraging the teen to talk about her loss.

5. True. Many teens will immediately try to protect themselves from the shock of a death by sending themselves and others little fake messages about how everything is
