Ada (Denton) Hudson

Ada Hudson, 100, a native of England, and former Colby resident, died Thursday, Oct. 9, 2008 in Garden City.

She was born February 24, 1908, to William and Florence Aldridge Denton in Sheffield, Yorkshire, England, and grew up there with her four brothers and four sisters.

She married Charlie Hudson in March 1933 in Worsborough Village, Yorkshire. They lived in Blacker Hill and later moved to Worsborough Bridge. He died in a coal mining accident in September 1941.

She continued to live in Worsborough Bridge until 1968, when she move to Colby to be near her daughter. While in Colby, she was

a volunteer and was a member of the Retired Senior Volunteer Program. She was known for her knitting projects and for taking tickets at the Colby Community College sporting events.

She attended the Colby United Methodist Church.

In July 2004, she moved to the Garden Valley Retirement Village in Garden City.

She also was proceeded in death by her her husband and all her siblings.

Survivors include her daughters, Leah and Mel Martinek, Garden, City, and Joanne and Kirwin

Jones, Goodland, five grandchildren, 12 great-grandchildren and a great-great-grandchild.

Burial was to be at 11 a.m. today, Monday, Oct. 13, 2008, at the Colby Cemetery. A memorial service will be held at the retirement home later.

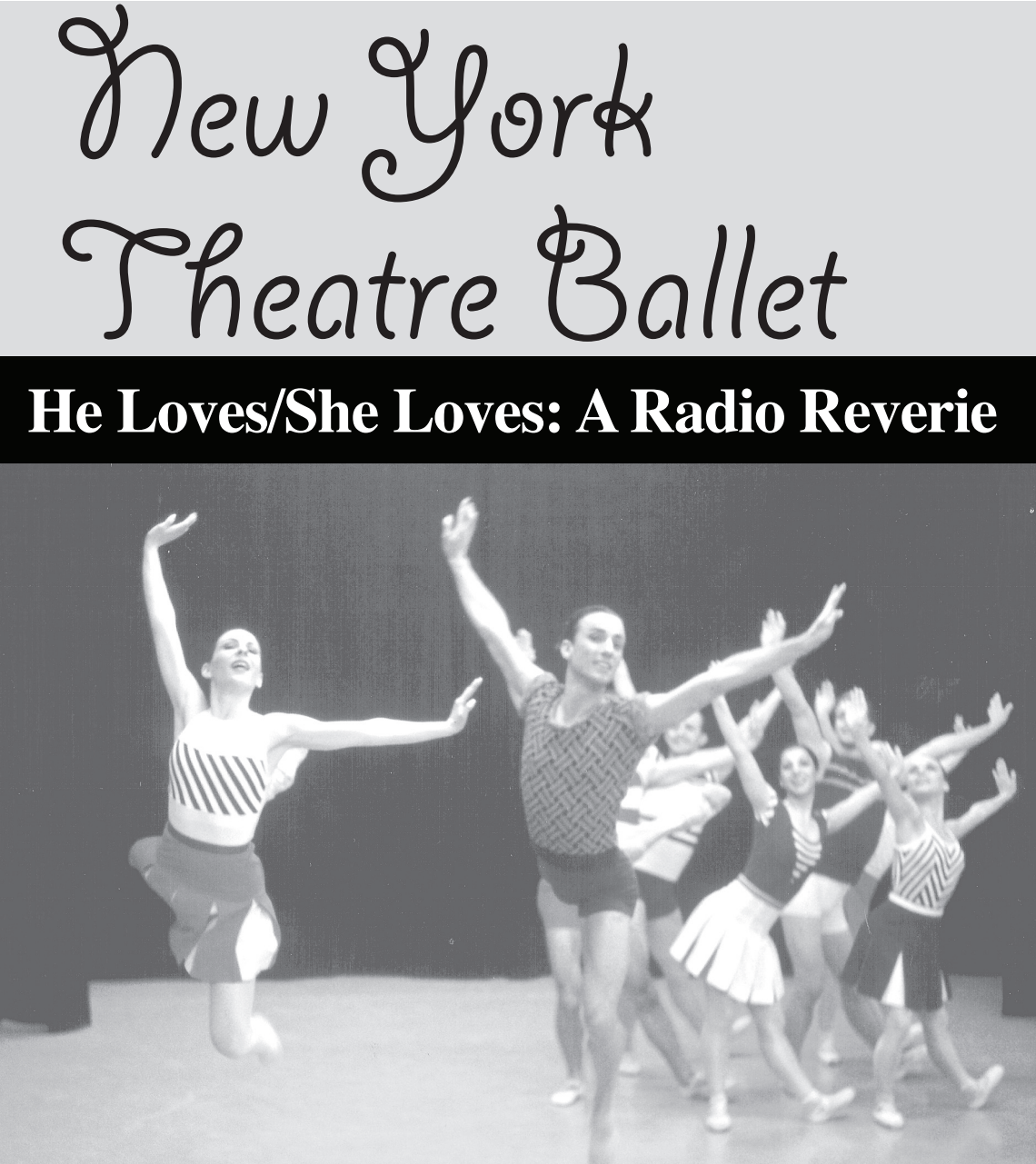
