Library to host signing by author on Saturday

An Oakley author will talk about her new book, "Accidentally Deliberate," at the Pioneer Memorial Library from 2 to 3 p.m. Saturday.

Jo Lynn Jamison said she was encouraged to write her story by her mother, Mary Lee Jamison, formerly of Oakley, but only after her death. She said her mother thought some of it, such as Jamison's brother's drug abuse, might be to hard for her to read. "I feel that I have lived an interesting life due to the fact that I suffered a lot of abuse in my life, both as a child, in an abusive marriage and when I was

mugged on the street," the author said. "I hope my story will help children and other women who are or have been abused."

The book also tells of Jamison's career as an entertainer, singing and playing the piano in lounges in Las Vegas, as a massage therapist and as the opening act for the Platters at Pearl Harbor in Hawaii in 1973.

One experience she mentions is when a friend sailed a 32-foot boat through the Bermuda Triangle and lived to tell about it. Jamison will be at the library from 9 a.m. to 4 p.m. to talk with people and to sign her books.
