### RESOLUTION NO. 977

A RESOLUTION FINDING THAT THE RESIDENTIAL STRUCTURE LOCATED ON LOTS FIFTEEN (15), SIXTEEN (16) AND SEVENTEEN (17), BLOCK NINETEEN (19), SOUTH PARK ADDITION TO THE CITY OF COLBY, KANSAS, AS SHOWN BY THE RECORDED PLAT THEREOF, COMMONLY KNOWN AND REFERRED TO AS 345 SOUTH SCHOOL AVENUE, COLBY, KANSAS, IS UNSAFE OR DANGEROUS AND DIRECTING THAT THE RESIDENTIAL STRUCTURE BE REMOVED AND THE PREMISES MADE SAFE AND SECURE.

**WHEREAS**, the Enforcing Officer of the City of Colby, Kansas did on the 16th day of September, 2008, file with governing body of said City a statement in writing that a certain structure, hereinafter described, was unsafe, dangerous, and unfit for human habitation; and,

**WHEREAS**, the governing body did by Resolution No. 970 dated the 7th day of October, 2008, fix the time and place of a hearing at which the owner, his or her agent, and lienholders, any occupants and all other parties of interest of such structure could appear and show cause why such structure should not be condemned and ordered repaired or demolished, and provided for giving notice thereof as provided by law; and,

**WHEREAS**, Resolution No. 970 was published in the official city paper on the 13th day of October, 2008, and on the 20th day of October, 2008, and a copy of said resolution was served upon all persons entitled thereto as provided by law; and,

**WHEREAS**, on the 2nd day of December, 2008, the governing body did conduct the hearing scheduled in Resolution No. 970 and took evidence from the Enforcing Officer on behalf of the city. The following parties in interest failed to appear and did not present evidence: Sharon Stupka, owner; Michael Cates, owner; Bobby Cates, occupant; John Stupka, attorney-in-fact for owners and occupants; and BankWest of Kansas.

**NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF COLBY, KANSAS, THAT:**

1. The governing body hereby finds that the residential structure located at:

All of Lots Fifteen (15), Sixteen (16) and Seventeen (17), Block Nineteen (19), South Park Addition to the City of Colby, Kansas, as shown by the recorded plat thereof,

and commonly known and referred to as 345 S. School, Colby, Kansas, is so infested and saturated with mice and/or dead mice, the remnants, feces and urine of mice, animal feces and urine, and emits such an offensive and nauseous odor as to be a health hazard as documented by City Health Official Gary D. Slavens, M.D., and the Enforcing Officer of the City of Colby, Kansas. The residential structure is unsafe, dangerous, and unfit for human use or habitation. The governing body directs that such residential structure is to be removed and the premises made safe and secure.

2. The owner of such residential structure is hereby directed to commence the removal of the property within thirty (30) days from the date of publication of this resolution (not later than the 20th day of January, 2009) and to have the removal completed within five (5) days of commencement (not later than the 25th day of January, 2009). Provided, that upon due application by the owner and for good cause shown, the governing body, in its sole discretion, may grant the owner additional time to complete the removal of the property.

**BE IT FURTHER RESOLVED**, that if the owner fails to commence the removal of the residential structure within the time provided herein or fails to diligently prosecute the same, the governing body may take such further action as it deems necessary to raze and remove the structure without further notice to the owner or other parties in interest.

**BE IT FURTHER RESOLVED**, that the City Clerk shall cause this Resolution to be published once in the official city paper and mail a copy to the owner, agents, lienholders, occupants, and other parties in interest.
