This screening test indicates if and treatment." further testing is needed so cancer can be detected and treated when it is curable. January is Cervical Cancer Awareness Month, and the Kansas Department of Health and Environment reminds women they should schedule an annual well-woman checkup.

"When cervical conditions are which is present in more than 99 discovered and treated at an early stage, the survival rate is nearly 100 percent," said Rod Bremby, secretary of health and envionment. "Cervical cancer is normally a very slow-growing cancer, and a Pap test can often detect precancerous cells which can be removed before the cancer has developed or spread."

Although the number of cervical cancer cases has declined in the cer screening for uninsured womlast 50 years, an estimated 4,600 women will die from cervical cancer in the U.S. this year. In Kansas women, cervical cancer accounts for about 2 percent of all cancer, with an average of 107 new cases each year.

About 35 percent of those occurred in women ages 55 and older. And and average of 33 Kansas women die of cervical cancer each year. It is important for women be tested for cervical cancer because six out of 10 cervical cancers occur in women who have never received a Pap test or have not been tested in the past five years.
