ORDINANCE NO. 1460

AN ORDINANCE AMENDING SECTION VIII - LEAVE, OF THE CITY OF COLBY PERSONNEL HANDBOOK, PERTAINING TO THE USE OF SICK LEAVE.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COLBY, KANSAS:

SECTION 1.

The Personnel Handbook for the City of Colby which includes employment practices, personnel policies, and grievance procedures was adopted, incorporated by reference, and approved by the City Council on December 6, 2005.

SECTION 2.

SECTION VIII - LEAVE, Subsection B. Sick Leave: 2. Use of Sick Leave, of the Personnel Handbook for the City of Colby is hereby repealed.

SECTION 3.

SECTION VIII - LEAVE, Subsection B. Sick Leave: 2. Use of Sick Leave, of the Personnel Handbook for the City of Colby is hereby amended to read as follows:

2. Use of Sick Leave. Sick leave may be taken upon accrual pursuant to the requirements set forth in this Section and, where applicable, in the Family and Medical Leave Act. If an employee is not eligible for Family and Medical Leave, any time earned under this Subparagraph B may be used, but only if the requirement of this section and the Family and Medical Leave section are followed. Employees who have exhausted their sick leave are required to exhaust all paid leave time available to them before being allowed to take leave without pay.

In order to receive compensation while absent on sick leave, employees shall notify their Department Head prior to or within one (1) hour after the time they were scheduled to begin work; if such notification is not made, and is not excused, the employee shall be considered absent without leave.

Employees leaving City employment shall not be compensated for accrued but unused sick leave.

SECTION 4.

This Ordinance shall take effect and be in force from and after its passage, approval, and publication as provided by law.
