County to replace court carpet soon

The Thomas County commissioners took advantage of a light agenda on Monday, so they could finish up business early and head for the harvest fields while the weather was good.

Sealed bids were opened for new carpeting for the Court Services office on third floor. The winning bid was Northwest Decorating at \$14,321. Judge Glenn Schiffner will pick out the color and do the scheduling to correspond with days the court will not be busy.

The other bid, from Office Works, was lower at \$13,529, but would have had the county reout of the way and back when the carpet is installed. The commissioners said they chose the higher

SALINA (AP) — The former director of the Salina Housing Authority has sued congressional candidate Alan Jilka, alleging she was fired for refusing Jilka's sexual advances.

In a federal lawsuit filed Oct. 13, Ann Rollins Johnson accuses Jilka of creating a hostile work environment and then orchestrating an effort to have her fired after she refused several sexual advances.

Jilka, a former mayor and city commissioner in Salina, is seeking the Democratic nomination for the 1st District congressional seat being vacated by GOP Rep. Jerry Moran. The lawsuit also names the city of Salina, the Salina Housing Authority and the housing authority's five board members.

Jilka told The Salina Journal on Monday that the accusations are "frivolous and preposterous."

Johnson was director of the housing authority from December 2000 until January 2008. She filed complaints last year with the Kansas Human Rights Commission and the federal Equal Employment Opportunity Commission.

In her lawsuit, Johnson contends that Jilka leered at her and other women at the Salina Housing Authority, asked her for confidential information about tenants of the authority and subjected Johnson to 'severe, pervasive and ongoing sexual harassment by and through a hostile work environment based on her sex or gender because she would not become involved romantically with Alan."

Johnson said she received a letter on Jan. 17, 2008.
