PHOENIX (AP) — A high school librarian in Phoenix says a former student returned two overdue books checked out 51 years ago along with a \$1,000 money order to cover the fines.

Camelback High School librarian Georgette Bordine says the two Audubon Society books checked out in 1959 and the money order were sent by someone who wanted to remain anonymous.

Bordine says the letter explained they were packed by mistake.

The letter said the money order was to cover fines of 2 cents per day for each book. That would total about \$745. It says extra was added in case rates had changed.
