Two Thomas County farms recognized for 100-year span

Two Thomas County farms were inducted into the Century Farm program in September at the Kansas State Fair, joining eight others in the county with more than 100 years of family ownership.


The Cleo Duffey farm near Menlo and the Henry Bremenkamp Jr. farm near Halford are the newest inductees. Across the state, the Kansas Farm Bureau has designated more than 1,900 Century Farms since 2000.

To be eligible, an applicant must be a member of the Farm Bureau, ownership must have been within the same family for 100 years or more on Dec. 31 and the present owner must be related to the original owner. Any family member who is a Farm Bureau member may apply to the bureau's county office.

Of the two, the longest-operating is the Duffey farm, homesteaded in 1885. Today it's operated by Cleo Duffey, 80, who still lived on the home place his grandfather settled.

John J. Duffey, grandfather of Cleo, came west from Page County, Iowa, to Cedarville in Smith County in 1883. In 1885, he ventured farther west to Thomas County to stake a claim on the northwest quarter of section 28-8-31, southwest of Menlo.

one child in Smith County in August of that year, Duffey came to Thomas County in a covered wagon with a team of horses and enough equipment to break the sod, enough seed to plant 25 acres of oats and barley, rations for his horses and himself and the equipment to cut sod to build a 16-by 26-foot house.

Family stories say he either made a dugout in a bank or lived in a cave that was already on the property while he prepared the claim where he would live and raise his family. It took until 1892 to receive the patent, or deed, from the government.

By the end of October, he was ready to return to Smith County to retrieve his wife and child - and a soon-to-be-born second child - and stay for the remainder of the winter months. The final trek to Thomas County began in the spring 1886, again by covered wagon, with the wife and two children with yet another on the way. This time, he brought \$5 and a cow he had purchased from the farmer he worked for, but had yet to pay for. He dug a well on the new property, where the family intended to stay for good.

"My granddad did business with gold pieces," said Freda Weyland, John's granddaughter, who lives in Norton. "There were no banks close by, so when he made a transaction, it was done with gold."

"He kept it rolled up into a ball of socks," said Loreda Wagoner, another granddaughter from Great Bend. "My dad used to tell how the kids were playing one day and found the 'sock ball' and were playing catch and keep-away with
