Walmart and Dillon grocery stores in Colby," said Doris Quenzer, store clerk, "and we were 11 percent higher than Walmart prices on like items."

Twenty-five dollars worth of groceries at Walmart would cost \$27.75 at the Brewster store, well worth the difference for having the local convenience.

Eighty-two grocery stores in Kansas have closed in communities of less than 2,000 population in the last three years.

City council in the market for sound system

In response to some complaints any action on the sound system. by basketball fans, the Colby City Council is considering a new sound system for the community building gym.

Brad Johnson of Sound Innovations gave a presentation Tuesday on the strengths of his company's sound system. Sound Innovations is a division of Midwest Music based in Salina.

City manager Carolyn Armstrong said she requested this proposal after receiving complaints about the quality of sound during the Orange and Black Classic bascompany's sound system would cost \$52,758 with city workers running some of the wiring.
