## City moves on airport extension

The city of Colby is moving praisal. forward with a project to expand the main runway at Shalz Field Municipal Airport.

The City Council, meeting Tuesday at City Hall, approved having HWS Consulting Group, the Manhattan engineering firm working on the project, negotiate with two firms to work on appraisals for land acquisition.

City Manager Carolyn Armstrong said the runway will be expanded from 5,109 feet to 6,200 feet. In order for the runaway project to be finished the city needs to buy land from property owners near the airport.

The two firms, Fletcher Simmons & Jeff Holgerson of Manhattan and Roger Turner from Wichita, were chosen after the engineers had interviewed 31 firms from Kansas and Nebraska, said firm will do the appraisals and the Wichita firm will review the work.

Driggs said 20 tracts need to be acquired near the airport, ranging from .08 of an acre to 89.3 acres. See "AIRPORT," Page 3

Driggs said his firm has checked with the Federal Aviation Administration and they said that 18 of the 20 tracts require a full ap-

HWS will send the appraisal firms a list of the property and they will write out contracts that the council will have to approve.
