

# Bulldogs dominate in Logan

Brewster sophomore Kasey Hoyt dominated in the 800-meter run at the Logan Invitational track meet on Tuesday, taking first with a time of 2 minutes, 41.88 seconds.

Hoyt followed up with a second-place finish in the 1,600 meters with 6:13.43. Junior Sheena Rall finished fifth in the shot put with a heave of 29' 1.25".

Running the 3,200 for the first time, freshman Amber Barrie came in fourth with 18:02.74. Also running was freshman Jasmine Staten.

The Lady Bulldogs finished eighth overall in the meet.

On the boys' side, freshman Dan Brown again improved in the high jump, clearing 5' 6" for fourth place. Brown ran a great 400-meter race, finishing second with 59.66. He finished sixth in the long jump with a leap of 16' 4.75".

Senior Spencer Holm ran the 300-meter intermediate hurdles for the first time this year, finishing third with 48.56. Holm took second in both the high jump, clearing 6', and the 110-meter high hurdles with 17.37, his best time this season.

Running the 1,600 in 5:32.33, freshman Michael Schmidt finished in second place. Schmidt came in fifth in the 3,200 meters with 12:59.26. Freshman Ben Baird was just a fraction of a second behind Schmidt in the 3,200, finishing sixth. Baird nabbed sixth in the 1,600 with 5:50.17.

The Bulldogs finished sixth overall.

Next track and field action for the Bulldogs will be at 3 p.m. today in the Colby Invitational at Dennen Field.
