AN ORDINANCE ADOPTING AND INCORPORATING THE UNIFORM PUBLIC OFFENSE CODE FOR KANSAS CITIES, EDITION OF 2010; REPEALING CHAPTER XI, ARTICLE 1, SECTION 101, OF THE MUNICIPAL CODE OF THE CITY OF COLBY, KANSAS, 2007 EDITION; AND REPEALING ORDINANCE NO. 1447.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COLBY, KANSAS:

**SECTION 1.** The Code of the City of Colby, Kansas which is a codification of the general ordinances of the City of Colby was adopted, incorporated by reference, and approved by the City Council on June 19, 2007.

**SECTION 2. Chapter XI. Public Offenses - Article 1. Uniform Offense Code - Section 11-101. Incorporating Uniform Public Offense Code of the Municipal Code of the City of Colby, Kansas, is hereby repealed.**

**SECTION 3. Chapter XI. Public Offenses - Article 1. Uniform Offense Code - Section 11-101. Incorporating Uniform Public Offense Code of the Municipal Code of the City of Colby, Kansas, is hereby amended to read as follows:**

### ARTICLE 1. UNIFORM OFFENSE CODE

11-101. INCORPORATING UNIFORM PUBLIC OFFENSE CODE. There is hereby incorporated by reference for the purpose of regulating public offenses within the corporate limits of the City of Colby, Kansas, that certain code known as the "Uniform Public Offense Code", Edition of 2010, prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas. No fewer than three (3) copies of said Uniform Public Offense Code shall be marked or stamped "Official Copy as Adopted by Ordinance No. 1481," and to which shall be attached a copy of this Ordinance, and filed with the City Clerk to be open to inspection and available to the public at all reasonable hours.

**SECTION 4.** Ordinance No. 1447 is hereby repealed.

**SECTION 5.** This Ordinance shall take effect from and after its passage and publication once in the official city newspaper.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COLBY, KANSAS:

### SECTION 1.

The Code of the City of Colby, Kansas which is a codification of the general ordinances of the City of Colby was adopted, incorporated by reference, and approved by the City Council on June 19, 2007.

### SECTION 2.

**CHAPTER VIII - HEALTH AND WELFARE. ARTICLE 1 - BOARD OF HEALTH. Section 8-101 entitled BOARD OF HEALTH CREATED of the Code of the City of Colby, Kansas is hereby repealed.**

### SECTION 3.

**CHAPTER VIII - HEALTH AND WELFARE. ARTICLE 1 - BOARD OF HEALTH. Section 8-101 entitled BOARD OF HEALTH CREATED of the Code of the City of Colby, Kansas is hereby amended to read as follows:**

### ARTICLE 1. BOARD OF HEALTH

8-101. BOARD OF HEALTH CREATED. The board of health shall consist of a city health officer, who shall be a practicing doctor of medicine, a physician's assistant or an advanced registered nurse practitioner, and two additional members who shall be members of the governing body. The city health officer and the two additional members of the board of health shall be appointed annually by the mayor at the first regular meeting of the governing body in April of each year, to serve for one-year terms subject to confirmation by the council; provided, that a member of the governing body appointed to the board of health shall have no right to vote for or against his or her own confirmation. The board shall adopt such rules and regulations as may be necessary to guide its operations. The city clerk shall be secretary of the board but shall have no vote. He or she shall preserve its records, rules and regulations and shall issue all orders and notices which may be required by ordinance or order of the board. (Code 2007; Ord. 1479)

This Ordinance shall take effect and be in force from and after its passage, approval, and publication as provided by law.

AN ORDINANCE REGULATING TRAFFIC WITHIN THE CORPORATE LIMITS OF THE CITY OF COLBY, KANSAS; INCORPORATING BY REFERENCE THE "STANDARD TRAFFIC ORDINANCE FOR KANSAS CITIES," EDITION OF 2010; PROVIDING CERTAIN PENALTIES; REPEALING CHAPTER XIV, ARTICLE 1, SECTION 101, OF THE MUNICIPAL CODE OF THE CITY OF COLBY, KANSAS, 2007 EDITION; AND REPEALING ORDINANCE NO. 1448.

WHEREAS, the City of Colby, Kansas, as authorized under K.S.A. 12-3009 through 12-3012, including any amendments thereon, K.S.A. 12-3301 and 12-3302, to adopt and incorporate by reference the Standard Traffic Ordinance for Kansas Cities, Edition of 2010, as prepared and published by the League of Kansas Municipalities; and,

WHEREAS, the Governing Body of the City of Colby, Kansas, finds it necessary and to the best interest of the City to adopt and incorporate by reference the said Standard Traffic Ordinance for Kansas Cities, Edition of 2010, as above described.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COLBY, KANSAS:

**SECTION 1.** The Code of the City of Colby, Kansas which is a codification of the general ordinances of the City of Colby was adopted, incorporated by reference, and approved by the City Council on June 19, 2007.

**SECTION 2. Chapter XIV. Traffic - Article 1. Standard Traffic Ordinance - Section 14-101. Incorporating Standard Traffic Ordinance of the Municipal Code of the City of Colby, Kansas, is hereby repealed.**

**SECTION 3. Chapter XIV. Traffic - Article 1. Standard Traffic Ordinance - Section 14-101. Incorporating Standard Traffic Ordinance of the Municipal Code of the City of Colby, Kansas, is hereby amended to read as follows:**

**ARTICLE 1. STANDARD TRAFFIC ORDINANCE**

14-101. INCORPORATING STANDARD TRAFFIC ORDINANCE. There is hereby incorporated by reference for the purpose of regulating traffic within the corporate limits of the City of Colby, Kansas, that certain standard traffic ordinance known as the "Standard Traffic Ordinance for Kansas Cities," Edition of 2010 prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas. No fewer than three copies of said Standard Traffic Ordinance shall be marked or stamped "Official Copy as Adopted by Ordinance No. 1480," and to which shall be attached a copy of this Ordinance, and filed with the City Clerk to be open to inspection and available to the public at all reasonable hours. The police department, municipal judge and all administrative departments of the City charged with enforcement of the Ordinance shall be supplied, at the cost of the City, such number of official copies of such Standard Traffic Ordinance similarly marked, as may be deemed expedient.

**SECTION 4.** Ordinance No. 1448 is hereby repealed.

**SECTION 5. EFFECTIVE DATE.** This Ordinance shall be in full force and effect from and after its publication in the official City newspaper as provided by law.
