## Republicans make clean sweep

The polls are closed, the results are in, and the Kansas Republican Party had exactly the big a night everyone had predicted.

Republican Sen. Sam Brownback and running mate Jeff Colyer handily won the governorship with 522,061 votes to Democrat state Sen. Tom Holland's 264,067, roughly 66 percent to 34 percent. In Thomas County, Brownback did even better, polling 1,969 votes to Holland's 461, roughly 81 percent to 19 per-

"Now, it's a difficult time for many Kansas families. Jobs are scarce and the future is uncertain," Brownback said, speaking from the Maner Conference Center in Topeka. "Jeff and I promise you an energetic administration focused on what's best for the people of Kansas, with a government serving the people, not the

Republican Jerry Moran, who has represented the Big 1st District of western Kansas in Congress for more than a decade, won a seat in the U.S. Senate with 70 percent of the vote. In Thomas County, he got 2,261 votes to Democrat Lisa Johnston's 218.

Republican state Sen. Tim Huelskamp was elected to the U.S. House of Representatives with 74 percent of the vote over Democrat Alan Jilka, former mayor of Salina. In Thomas County, he got 2,016 votes to Jilka's 444.

Republican incumbent Lynn Jenkins won the 2nd District congressional seat and Republican candidates Kevin Yoder and Mike Pompeo won the 3rd and 4th Districts.

Republicans also took the three state government positions held by appointed Democrats:


Kris Kobach will be the new Kansas secretary of state, winning with 59 percent of the vote. Secretary of State Chris Biggs got 37 percent. In Thomas County, Kobach won See "SWEEP," Page 3

Attorney General Steve Six lost the closest of the three races to challenger Derek Schmidt, 453,558 votes to 341,973. In Thomas County, Six lost 1,799 to 646.

Challenger Ron Estes beat state Treasurer Dennis McKinney, 58 percent to 42. Here he got 1,696 votes to McKinney's 753 here.

Unopposed incumbent Sandy Praeger, a veteran Republican, got 2,228 votes for insurance commissioner in Thomas County and Sally Cauble got 2,095 votes for Kansas Board of Education in District 5.

Republican Jim Morrison of Colby won reelection to the Kansas House of Representatives unopposed with 5,675, votes. In his home county he got 2,207 votes. Register of Deeds Lora Volk was re-elected with 2,376 votes and County Commissioner Byron Sowers with 777 votes in District 1, both running without

## Wind farm road pact to go before townships

The Thomas County commissioners finished work on a road-condition agreement with Solomon Forks Wind Farm covering possible damage to county roads that will be affected by wind-tower construction crews during their meeting Monday.

The four townships involved, Lacey, Morgan, Summers and North Randall, can either sign on their own authority or give all authority to the county. As of Monday morning, those decisions had not been made by the township boards.

"The signing isn't ultimate approval to begin building," said Tiff Thompson, project manager for Solomon Forks.

She said the firm's development plan must first be made available for public comment. She said the See "ROAD," Page 3

company is still optimistic about finding a buyer or buyers for the power to be generated by the farm, although none has signed on the dotted line yet.

Sunflower Electric Power Corp., a regional cooperative based in Hays, is one of the potential buyers. Peter Keenon of Acciona Energy, the Spanish firm behind the farm, said the price is low, so this is the time to buy. He said he believes there is a place for renewable energy in the Sunflower portfolio. He noted that Midwest Energy gets a lot of its power from Sunflower Electric, but the big power users are in eastern Kansas. So far, no start date has been set for construction.

The commissioners approved sending letter of support for the project to Sunflower.

## Judge tosses out supreme court lawsuit

a constitutional challenge to the way Kansas nominates its appellate justices.

U.S. District Judge Monti Belot on Wednesday dismissed a lawsuit claiming the state's judicial nominating process gives lawyers too much power and violates voting rights.

WICHITA (AP) – A federal judge has tossed out the debate over whether judicial nominees should be popularly elected. He says there is no evidence that the Kansas system has led to unqualified people being appointed to the Kansas Supreme Court and the Kansas Court of Appeals.
