AN ORDINANCE AMENDING SECTION 1-601 OF THE CODE OF THE CITY OF COLBY, KANSAS, WHICH ADOPTS AND INCORPORATES BY REFERENCE AS PART OF THE CODE OF THE CITY OF COLBY, KANSAS, THE PERSONNEL HANDBOOK OF THE CITY OF COLBY, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COLBY, KANSAS:

SECTION 1. Section 1-601 of the Code of the City of Colby is hereby amended to read as follows:

PERSONNEL HANDBOOK. The Personnel Handbook for the City of Colby which includes employment practices, personnel policies, and grievance procedures, as modified and amended by ordinance or resolution to this date, is hereby adopted and incorporated by reference.

SECTION 2. Section 1-601 of the Code of the City of Colby is hereby repealed.

SECTION 3. This Ordinance shall be in full force and effect from after its publication in the official city paper as provided by law.
