Superintendent Terrel Harrison told the Colby School Board the state association is urging members to hold public meetings on the "suitable education" issue the Legislature is dealing with, but she doesn't think that will stir up much interest.

The board held two "informational" meetings on school finance at Colby High School last year, she said. One was poorly attended; the other drew a larger audience. Harrison said at a board meeting Monday she would rather write a column for the *Colby Free Press* and send information home

Since the legislative session began in January, she said, lawmakers have been debating what the phrase "suitable education" means in the Kansas Constitution. The Kansas Association of School Boards' current concern is with HCR 5010. This "concurrent resolution," proposing an amendment to the state Constitution, was passed with a favorable recommendation by the House Education Committee on Tuesday.

Ten Colby High students qualify for forensics nationals

Ten Colby High School students qualified for a national forensics tournament at the Kansas Catholic Forensics League – Salina Diocese qualifier here last

The team placed third behind Republic County and Salina Central high schools out of 13 in the tournament. All of Colby's competitors made it to semifinals and all but two made it to the finals Saturday afternoon.

Colby woman reappointed to board

Sheila Frahm of Colby has been reappointed to the Kansas Postsecondary Technical Education Authority by the state Board of Regents.

The authority was created by the Kansas Legislature in 2007 to coordinate statewide planning for technical education under the regents.

Frahm was appointed to the authority when it was formed to represent the state's community colleges. This is her second three-year appointment.

A Fort Hays State University graduate, she has served in many civic roles, including terms on the Colby School Board, the state Board of Education and three in the Kansas Senate.

In 1996, while serving as lieutenant governor under Gov. Bill Graves, Frahm was appointed to the U.S. Senate to fill a vacancy caused by the resignation of Sen. Bob Dole. She lost a bid for re-election to Sam Brownback, now Kansas governor.

She served as executive director of the Kansas Association of Community College Trustees from 1997

"I am pleased to have been re-appointed," Frahm said. "Career technical education plays a vital role in developing the highly skilled and educated workforce necessary for the Kansas economy."
