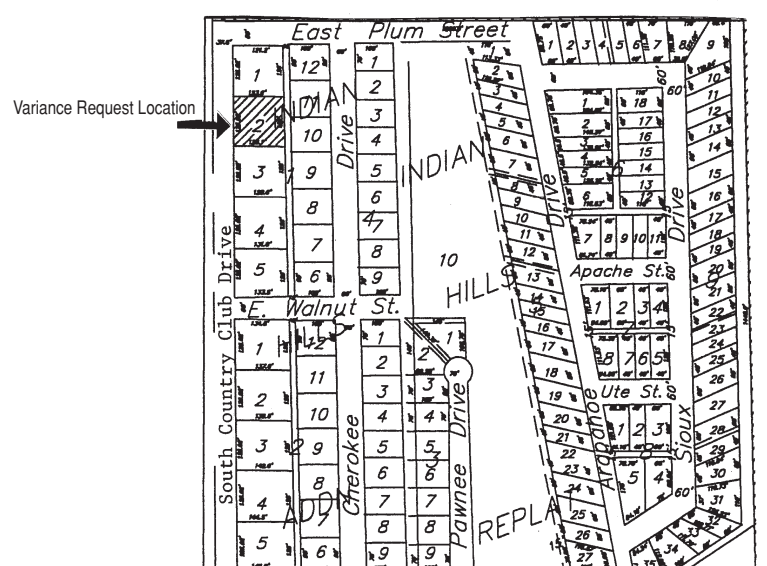
### NOTICE OF PUBLIC HEARING
