# School board considers swim team

Colby High School could get an officially sanctioned swim team this spring, but the proposal is far from a lock.

School Board Vice President Tracy Rogers brought the proposal to the board at Monday's meeting, saying the idea of a swim team has been around for years.

"There hasn't been a good time to add anything," he said.

# Rider killed in Norton race

A New Mexico man died Saturday evening after crashing his motorcycle during the flat track races at the Elmwood Park Speedway in

Few details of the incident have been released, but a race organizer reported that the man, whose name and age were unavailable, crashed his motorcycle on turn three at the

The rider was transported to the Norton County Hospital for evaluation of what appeared to be non-life threatening injuries. The man died at the hospital, however, from what may have been internal chest injuries from the impact of the motorcycle landing on his body during the crash.

Kansas Highway Patrol Trooper Perry Frey of Goodland was honored earlier this month for his actions in a rolling shootout in January that ended north of Brewster.

Frey was given the Superintendent's Award at a ceremony in Hays on Aug. 3 in recognition of his efforts on Jan. 16 when he was involved in a high-speed chase with a vehicle occupant firing at

Frey had checked on a vehicle in the Sherman County eastbound rest area on I-70 and found the registration did not match the vehicle. While he was talking with the occupants, the driver sped away.

Early in the pursuit, the driver stopped the vehicle in an attempt to get Frey to approach, with the intent of shooting the trooper.

#### State wants grant money to promote marriage

TOPEKA (AP) - At the same time as Gov. Sam Brownback's administration announced it would return a \$31.5 million federal grant that would help implement the new health care law, it was applying for a \$6.6 million federal grant to promote marriage.

When Brownback announced last week that the state would reject the health care grant, he cited a concern that the federal government would not be able to meet its financial commitments. He also said states should be preparing for fewer federal dollars, not more.

But those concerns did not prevent the Kansas Department of Social and Rehabilitation Services from seeking \$2.2 million a year for three years to pay for counseling that encourages unwed parents to marry, The Kansas City Star reports (http://bit.ly/oXgJTl ). State
