Commissioner Paul Steele presented a letter he found from about 2000 stating the conditions of the jail.

"We've known for 12 years that the jail was a problem," said Steele, adding that the jail was built before the present commissioners' time, but a solution to the problem is long overdue.

"I've estimated that we spend about \$52,000 per year for prisoner care elsewhere," said Steele, "and that doesn't include salary, fuel or meals to transport them. We are easily spending a jail payment already.'

Commissioners told Haas that the county has about \$350,000 in reserves that they could use for the project. Taylor has said that about the same amount is available in the drug forfeiture There were so many people fund.

Based on these concerns, the commissioners and Haas focused on the second of four financial options presented. Haas described the development of a three- to nine-member Public Building Commission to build and borrow money for the jail. Haas said that county commissioners could sit on that board or they could appoint others for it.

This commission would be given authorization to issue bonds for the purpose of building a jail. Any opponents could issue a notice of protest petition within 30 days to force an election, he said. "I'm going to Oberlin this af-

ternoon," said Haas, "who are considering this option to finance a swimming pool.

"This alternative is readily accepted in the market, and investors understand it, which allows for such attractive interest rates. Financing could be in place in 90 to 120 days if there is no protest."
