ORDINANCE NO. 180

AN ORDINANCE APPROVING ADOPTING NEIGHBORHOOD **REVITALIZATION PLAN FOR THE** REXFORD, KANSAS CITY OF AND ALL PROVISIONS, TERMS AND CONDITIONS THEREOF, AND AUTHORIZING THE EXECUTION OF A CERTAIN AGREEMENT FOR INTERLOCAL COOPERATION WITH THOMAS COUNTY, KANSAS AND ALL PARTICIPATING PUBLIC AGENCIES FOR THE PURPOSE OF PROVIDING A PROGRAM FOR NEIGHBORHOOD **REVITALIZATION.**

WHEREAS, The Kansas Neighborhood Revitalization Act as set forth in K.S.A. 1996 Supp. 12-17, 114 et. seq. authorizes and empowers the Governing Body of the City of REXFORD, Kansas (herein CITY) to designate any area within the CITY as a Neighborhood Revitalization area if the Governing Body finds that one or more of the conditions described in of K.S.A. 1996 Supp. 12-17, 115 (b) exists thereby encouraging and facilitating the rehabilitation, conservation and redevelopment of any such designated area and also, thereby protecting and promoting the public health, safety and welfare of the residents of the CITY; and,

ANORDINANCEAMENDINGCHAPTER XII, ARTICLE 1, TO ADD SECTION 12-113 THROUGH AND INCLUDING SECTION 12-115, PROHIBITING THE USE OF SKATEBOARDS ON THE WALKING TRAIL LOCATED IN BLOCK ONE (1), DAVIS FAMILY LEGACY SUBDIVISION, IN THE CITY OF COLBY THOMAS COUNTY, KANSAS, ALSO KNOWN AS THE COLBY AQUATIC PARK SITE.

WHEREAS, the Governing Body of the City of Colby, Kansas, has determined that the operation of skateboards on the walking trail located within the City of Colby, Kansas, may endanger persons using said trail; and

WHEREAS, for the purpose of this Ordinance, the term "skateboard" defined as all wheeled objects, coasters, scooters, conveyances, or similar devices used for transportation or sport which are not classified or considered to be bicycles, roller skates, baby strollers, wheeled chairs or other conveyances controlled by the user's hands.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COLBY, KANSAS THAT THE FOLLOWING SECTIONS ARE HEREBY ADDED TO CHAPTER XII. PUBLIC PROPERTY, ARTICLE 1, CITY PARKS, IN THE COLBY MUNICIPAL CODE:

Section 12-113: That the use of skateboards on the walking trail located in Block One (1), Davis Family Legacy Subdivision, in the City of Colby, Thomas County, Kansas, also known as the Colby Aquatic Park Site, is hereby prohibited.

Section 12-114: That signs shall be posted or erected at entrance points on the walking trail advising that skateboards are prohibited.

Section 12-115 That it shall be unlawful for any person to violate or fail to comply with any provision of this Ordinance and failure to comply shall result in a fine of not less than \$50 nor more than \$500 per violation.

This Ordinance shall take effect and be in force from and after its passage, approval, and publication as provided by law.
