**WHEREAS** on the 5th day of July, 2012, the Board of Commissioners of Thomas County, Kansas finds that certain conditions have caused, or imminently threaten to cause wide-spread or severe damage, injury or loss of life or property in disaster proportion in Thomas County, Kansas;

**WHEREAS,** such dry conditions have created obstructions which endanger health, safety and welfare of persons and property within the border of Thomas County, Kansas.

**Now, therefore, be it resolved by the Board of Commissioners of Thomas County, Kansas:**

That the Board of County Commissioners of Thomas County, Kansas, under and by virtue of the authority vested in it by K.S.A. 1976 Supp. 48-932, does hereby PROCLAIM that a State of Local Disaster Emergency exists & that a Burn Ban is in place.

**IT IS FURTHER RESOLVED AND PROCLAIMED** that the area within the border of Thomas County, Kansas covered by this proclamation/resolution is the entire area of Thomas County, Kansas.

**BE IT FURTHER RESOLVED** that said Board has all rights and/or powers to perform such functions as are vested in said Board by and through the provisions of the Kansas Emergency Preparedness Act of 1975.

**IT IS FURTHER RESOLVED AND PROCLAIMED** that this resolution shall cover all open burning of any kind. The resolution shall remain in effect for an indefinite time period unless terminated earlier or renewed by consent of the governing body.
