# Water meeting set in Hoxie

Eighteen property owners in Thomas County and many more in Sheridan County may be affected by new water restrictions they had a hand in developing.

Beginning Jan. 1, and for the next five years, said Wayne Bossert, manager of Northwest Kansas Groundwater Management District No. 4, the district known as the Sheridan County No. the first Local Enhanced Management Area water restriction authorized under a new Kansas law.

The affected area includes Sections 22-27 and 34-36 in Township 8 South, Range 31 West, in Menlo Township. However, the majority of the plan affects Sheridan County property owners.

The area is one of six in the groundwater district identified as having withdrawal rates exceeding the recharge rate and a higher decline rate than the district average, Bossert said.

TRENTON, N.J. - Federal agents arrested the mayor of New Jersey's capital city early today as part of an ongoing corruption investigation into bribery allega-

tions related to a parking garage project that was concocted as part of an FBI sting operation.

Trenton Mayor Tony Mack, his brother Ralphiel and convicted sex offender Joseph Giorgianni, a Mack supporter who owns a Trenton sandwich shop, were accused of conspiring to obstruct, delay and affect interstate commerce by
