Are you prepared for any emergency?

September is National Preparedness Month. Would you be ready if there were an emergency?

Be prepared: assemble an emergency supply kit, make emergency plans, stay informed and get involved in helping your family, your business and your community be ready for emergencies.

Create a Grab-and-Go Box

If you had only a few moments to evacuate your home, would you have access to the cash, banking services and the personal identification needed to conduct your day-to-day financial life? Consider keeping the following items in a secure place in your home, in a waterproof, fireproof container that can be taken with you at a moment's notice.

- Identification and documents to restore financial records, including copies of your driver's license, passports, social security cards
- Insurance cards, policies or other proof of insurance coverage
- Household inventory
- Immunization records
- Bank account numbers, cash
- Copies (front and back) of ATM, debit and credit cards
- Phone numbers and account information for all financial service and insurance providers
- Important telephone numbers (family, doctors, veterinarians)
- Names and prescription numbers for medications
- Safe deposit box key
- Small notebook and pencil

If the following items are not kept in a safe deposit box, these should also be kept in your grab-and-go box. It is a good idea to make copies of safe deposit box contents in case the originals are damaged by water.

- Family records (birth, marriage, death certificates)
- Will, contracts, deeds, stocks and bonds
- Titles to vehicles

Family Communications

Your family may not be together when disaster strikes, so plan how you will contact one another. Think about how you will com-

municate in different situations.

Complete a contact card for each adult family member. Have them keep these cards handy in a wallet, purse or briefcase. Complete contact cards for each child in your family. Put the cards in their backpacks or book bags.

Check with your children's day care or school. Facilities designed for children should include identification planning as part of their emergency plans.

Family Communication Tips

Identify a contact, such as a friend or relative who lives out of state, for household members to notify that they are safe. It may be easier to call long distance than across town, so this contact may help communicate among separated family members.

Be sure every member of your family knows the phone number and has a cell phone, coins or a prepaid phone card to call the emergency contact. If you have a cell phone, program that person(s) as "ICE" (In Case of Emergency) in your phone. If you are in an accident, emergency personnel will often check your ICE listings to get hold of someone you know.

Make sure to tell those you've listed as emergency contacts.

Teach family members how to use text messaging. Text messages can often get around network disruptions when a phone call might not be able to get through.

Subscribe to alert services. Many communities have systems to send instant text alerts.

A disaster can happen at any time of the year. So take action now to get prepared before it happens. For tips go to the Extension Disaster Education Network (EDEN) website at eden.lsu.edu.

Niel 'Dean' Larsen

Niel "Dean" Larsen, 79, Colby, died Sunday, Sept. 9, 2012, at the Prairie Senior Living Complex in Colby, one day before his 80th birthday.

He was born Sept. 10, 1932, to James J. and Pearle (White) Larsen on a farm on the Middle Fork of the Sappa Creek in Rawlins County. Following high school, he worked for the Colby K-State Experiment Station.

He served two years in the Korean War, from 1953 to 1955. When he came home, he went back to work for the experiment station and also on the family farm.

On Jan. 29, 1956, he married Patricia Henningsen at the Colby United Methodist Church. In 1981, he retired from the experiment station and went to farming full time.

Preceding him in death were two brothers, Earle and Glenn

Larsen, and three sisters, Mildred Jones, Ruth Brickley and Dorothy Schippert.

Survivors include his wife, of the home; two daughters, Mylinda (Harlan) Downing and Sondra Stephens, both of Colby; a son, David (Deborah) Larsen, Purcellville, Va.; two sisters, Frances Smith and Nancy (John) Sanders, Colby; a brother, Norman (Carolyn) Larsen, Kansas City, Kan.; four grandchildren; and a great-grandson.

Services will be at 10 a.m. Thursday, Sept. 13, 2012, at the Baalmann Mortuary in Colby, followed by burial in the Beulah Cemetery with military honors.

Visitation was to be from 2 to 7 p.m. today at the mortuary.

The family suggests memorials to the nursing home instead of flowers, in care of the mortuary, Box 391, Colby, Kan., 67701.
