SUMMARY OF ORDINANCE NO. 1520

On May 7, 2013, the governing body of the City of Colby, Kansas passed an ordinance entitled:

AN ORDINANCE LEVYING SPECIAL ASSESSMENTS ON CERTAIN PROPERTY TO PAY THE COSTS OF INTERNAL IMPROVEMENTS IN THE CITY OF COLBY, KANSAS, AS HERETOFORE AUTHORIZED BY RESOLUTION NO. 1055 OF THE CITY; AND PROVIDING FOR THE COLLECTION OF SUCH SPECIAL ASSESSMENTS.

The Ordinance levies special assessments on certain property located in Cooper First Addition to the City of Colby, Thomas County, Kansas, which have been benefitted from certain internal improvements constructed pursuant to K.S.A. 12-6a01 et seq. A schedule of the amounts of said special assessments and the property benefitted are attached to the Ordinance. Any amount of special assessments not paid within the time prescribed in the Ordinance shall be certified by the City Clerk to the Clerk of Thomas County, Kansas, in the same manner and at the same time as other taxes are certified and will be collected in annual installments, together with interest on such amounts at a rate not exceeding the maximum rate therefor as prescribed by law.
