Appraiser's office gets new pickup

The Thomas County Commissioners approved the purchase of a new pickup for the County Appraiser's office at the commission's Friday meeting.

The vehicle, a 2013 Ford F150 Super Cab 4x4, replaces the county's 1994 Ford Ranger, purchased in 1994. Tubbs and Sons Ford Sales won the purchase contract with a bid of \$23,575.60 over Colby Dodge's bid of \$24,973 for a 2013 Ram 1500 Quad Cab. Prices from both bidders included special gov-

ernment discounts.

The appraiser's office will use the pickup for data collection, said Kathy Cunningham.

The commissioners also approved the addition of unpaid noxious weed bills to the tax rolls for five properties. According to weed supervisor Clair Schrock, property owners Victor and Brenda Mazanec owe \$2371.99 on two properties; Chuck and Julie Saddler owe \$703; Stephen and Tracy Shull owe \$103.50; and Marvin Urban owes \$121.75.

If the debts are not paid by June 15, the county will add a 10 percent penalty to each unpaid bill and place a lien on the properties.

In other business, the commissioners:

• Instructed the sheriff's department to ignore the city fire marshal's request for an annual load test on the generator at the jail since the generator's load is already tested regularly as part of a maintenance agreement.

• Interviewed Kathy Kennedy, a candidate for the open appraiser position. Kennedy lives in Oakley and previously worked in Thomas County as a district appraiser. The commission is scheduled to make a hiring decision at its Monday, meeting.

Highways to be sealed

Two bids approved for state highway maintenance projects by the Kansas Department of Transportation May 22 in Topeka will have an impact on our area.

The first, in Thomas County, is to seal 11.5 miles of U.S. 83 from the Nine Mile Corner north to the Sheridan County line. The contract was awarded to Blevins Asphalt Construction Company of Mt. Vernon, Mo., for \$330,882.67.

The second project is to seal 11.4 miles of K-25 in Logan County, from mile marker 145.8 east to the city limits of Russell Springs. That contract also went to Blevins, for \$261,404.50.

According to Kristen Brands of the department's Norton office, both projects are expected to be done late this summer.
