ORDINANCE NO. 1524

AN ORDINANCE ATTESTING TO AN INCREASE IN TAX REVENUES FOR BUDGET YEAR 2014 FOR THE CITY OF COLBY

WHEREAS, the City of Colby must continue to provide services to protect the health, safety, and welfare of the citizens of this community; and

WHEREAS, the cost of providing essential services to the citizens of this City continues to increase.

NOW THEREFORE, be it ordained by the Governing Body of the City of Colby:

Section 1. In accordance with state law, the City of Colby has scheduled a public hearing and has prepared the proposed budget necessary to fund city services from January 1, 2014 until December 31, 2014.

Section 2. After careful public deliberations, the Governing Body has determined in order to maintain the public services that are essential for the citizens of this City, it is necessary to budget property tax revenues in an amount exceeding the levy in the 2013 budget.

Section 3. This Ordinance shall take effect after publication once in the official City newspaper.

Passed and Approved by the Governing Body on this 6th day of August, 2013.
