NOTICE OF PENDING FORFEITURE. Pursuant to K.S.A. 60-4109 of the Kansas Standard Asset Seizure and Forfeiture Act K.S.A. 60-4101 et seq.

TO: Ryan Nelson Laine, 3216 Palm Dr., Delray Beach, FL, 33483; to all other unknown persons who may claim an interest in the following property:

Notice is hereby given that property, \$2,860.00 US Currency, has been seized for forfeiture and is pending forfeiture to the State of Kansas pursuant to the Kansas Standard Asset Seizure and Forfeiture Act (KSASFA), K.S.A. 60-4101 et seq. If you have not previously received a Notice of Seizure for Forfeiture, this constitutes notice pursuant to the Act. The defendant's property was seized on or about June 18, 2013 in Thomas County, Kansas. A Notice of Pending Forfeiture is sufficient to begin this civil action and to seek out possible claimants to the seized property.

The conduct giving rise to forfeiture and/or the violation of law alleged is: Possession of a Hallucinogenic Drug with Intent to Distribute, K.S.A. 21-5705(a)(4). Plaintiff will further allege that a presumption of forfeitability exists pursuant to K.S.A. 60-4112(k).

You are hereby notified that the Plaintiff's Attorney has chosen to initially proceed with this matter administratively and is making stipulation of exemptions available for the

property seized for forfeiture as described above. Therefore,

You may do either of the following:

- File a verified legal claim with the District Court of Thomas County, Kansas, the Plaintiff's Attorney and the contact person for the seizing agency, clearly identifying the property you seek to claim. This claim must be in affidavit form and include all information required by K.S.A. 60-4111. This claim shall be mailed via certified mail, return receipt requested. The addresses for the Court and seizing agency are as follows: **Seizing Agency Contact:** Thomas County Sheriff's Office, 225 N. Court, Colby, KS 67701, **Thomas County District Court,** 300 N. Court Street, P.O. Box 805, Colby, KS 67701; OR
- Do nothing.

The law further provides for provisional return of property under certain circumstances including the posting of a surety bond or court hearing on whether probable cause existed when the property was seized. You may wish to consult with an attorney before deciding what is best for you. However, if no claim is filed within thirty (30) days of the publication of this Notice, any interest you may have in the property described above will be forfeited. Again, all claims shall comply with the strict requirements for claims set forth in K.S.A. 60-4111.
