# Tax boost surprises landowners

Some Thomas County landowners received a surprise in their mailboxes recently, tax bills that were much higher than they expected.

Over the last few weeks, Thomas County offices have been getting calls from confused and irritated owners wanting to know why their taxes have increased so much.

Commissioner Byron Sowers said he recently got a call from an upset constituent asking about tax increases, and Commissioner Mike Baughn said he had received questions about township levies increasing. The county appraiser's, treasurer's and clerk's offices also reported complaints.

depending on the taxpayers' situation, officials said, including where they live and the type of property they own. Since real estate taxes are paid in arrears, after the year they are assessed, landowners may not have noticed the changes until their tax bills came

this month.

For example, residents of Morcolby.society@nwkansas.com gan Township, which covers the central part of the county, saw a 389 percent increase in their township levy - from 4.364 in 2012 to 21.340 in 2013. Each township board sets its township's levy rate based on planned spending for the year, officials said.

Other landowners are noticing changes because their property valuation increased, said Deputy Appraiser Kathy Cunningham.

Agricultural land values generally increased last year based on a state calculation of farm land values that incorporates factors like crop prices.

Cunningham said some properties were re-evaluated over the last year, too, and the evaluation crew discovered some situations where farm buildings had been er-Reasons for each increase vary, roneously designated as residential buildings.

> When the errors were discovered, the buildings were re-categorized as agricultural, changing the assessment rate from 11.5 percent to 30 percent, said Cun-

All of the foundation's money goes to provide grants for citizens except for minor administrative costs for paper, stamps and banquet expenses, Mallory said. Board members are all volunteers and they have no staff.

## County wages up 3 percent

County employees will get another wage increase next year after Thomas County commissioners approved a 3 percent cost-of-living increase for every county employee at their meeting Tuesday.

The commissioners had previously discussed giving a set amount to each department instead of increasing salaries across the board. This would have allowed each department head to set increases based on each employee's performance.

But the commissioners decided to give overall raises, setting each employee's pay rate for 2014 by approving the salaries as listed on crease of \$1,000 a month for Araa spreadsheet reviewed by Commissioner Mike Baughn.

Baughn initially supported the idea of giving department heads authority to distribute the 3 percent raise among their employees, but changed his mind after discussions with other commissioners.

"Salaries need to be set in cement by this board," said Commissioner Paul Steele, indicating the group should table the issue if each employee was not to be given a 3 percent raise. A motion to table the issue failed.

Baughn then moved to approve the universal raise, citing a lack of participation from department heads. He said he had not heard from any department heads that they wanted authority to allocate raises, so he voted in favor of establishing the set 3 percent raise for every employee.

The commissioners also voted to give a raise to Autumn Arasmith, the county's emergency management director, after she obtained state certification.

The group first passed an insmith based on their recollection that she was promised such an in-
