Choose your tree with thoughtful eye

It's that time of year

Which time you say? It's Christmas season, and many will soon be buying a real Christmas tree. There are a couple

of ways you can get a real tree this year. I

encourage going to a tree farm because it's hard to know where cut trees came from and how long it's been since they were cut.

Dryness and freshness can also be a factor when buying them off a tree farm, but here are a few tips that can help you pick a fresh tree this year.

Before you decide to go out and choose your tree, measure the space where the tree is going to be placed in your home. Make sure the tree you purchase is going to fit, while also checking what size of base you have so it will fit that as well.

There are many Christmas tree species out there and not all are created equal. White pines are soft and attractive, but will not hold larger, heavier ornaments. Evergreens that have good needle retention include white spruce, Fraser fir, Colorado blue spruce, Concolor fir, balsam fir, Scotch pine, and Noble fir.

Each species of tree has a different way of showing if it is fresh. Bending some of the needles on the tree is a good way of telling if it's dry. The needles should not break if it's a pine. On other species it can be just the opposite; green needles should break crisply when bent.

Another way to tell you have chosen a fresh tree is to take a good sniff into the tree. If the tree smells musty, put it back and keep looking.

And last, check the bark to see if it looks fresh. If it has started to wrinkle, it may be dry and you should keep looking.

It is best to get to the tree lot soon after it opens. This will insure that most of the trees will be fresh and offer a wider choice. Finding a tree that has been stored in the shade means the tree has been kept cooler and moisture loss reduced.

If you suspect that the tree you have chosen is dry or not fresh, just keep looking. This is another from a tree farm, so you can ask the grower lots of questions.



tor is going to be water. We recommend making a fresh cut a half inch from the bottom. A v-shaped cut will not increase water uptake to the tree; creating this cut will make it more difficult to put in a stand and will actually decrease water uptake. I also advise against drilling a hole in the base of the tree as this will not help water uptake either. While setting up your tree, take your time and ensure that it will not fall or become a hazard.

In the first days your tree is going to need a lot of water. Check the tree every six to 12 hours, making sure the water is not below the base of the tree.

There are many additives suggested such as bleach and sugar, but they really don't extend the life of the tree. Water is the secret to ensure the life of your tree. Also keeping the tree out of direct sunlight, away from heat sources, and using low-heat lights is good practice to keep the tree fresh. If the tree becomes dry, you will need to remove it from your home because it will become a fire risk.

Having a real Christmas tree in your home is enjoyable and gives the feel that the Christmas season is here, but always ensure that it does not become a hazard or problem as we want everyone to have a safe Christmas season this year.
