Health screenings

Citizens Medical Center, working with the Thomas County Coalition, will offer health screenings from 6 to 9 a.m. Thursday, Friday, Saturday and Monday, Jan. 9, 10, 11 and 13, in the Citizens Medical Center Specialty Clinic Lobby. Screenings include:

• Comprehensive profile, including a lipid profile, glucose and complete blood count. Requires 10 to 12 hours fasting, \$30.

• TSH (thyroid), recommended for baseline or if having symptoms, \$20.

• Hgb A1C, three-month glucose average, for known diabetics or those with significant history, \$20.

• Prostate screening, PSA, males only, \$25. • EKG, recommended for baseline, \$35.
