Goodland Daily News In addition to city and school board contests, the question of removing the property tax lid in Sherman County is on the Tuesday election ballot along with a constitutional amendment referred by the state legislature.

The constitutional amendment is to specifically authorize cities and counties to allow the exemption from property taxation of equipment used in the development, exploration and production of oil and gas.

Currently the exemption from property tax is used exclusively for economic development purposes.

Sherman County is seeking citizen

approval of a resolution to remove the three candidates for the council posiaggregate tax lid which was imposed by the state legislature in 1989. The commissioners feel this is necessary to allow them to handle changing requirements and services they did not have 10 years ago.

Those against the removal of the tax lid feel the commissioners have been able to work under it and there is no reason to change the status quo.

Soldiers appear in court today

BELGRADE, Yugoslavia (AP) Yugoslavia began court proceedings against three captured U.S. soldiers today as NATO warplanes struck deep inside Serbia. Miles-long lines of refugees were reported backed up at Kosovo's borders.

Serb officials began gathering evidence today against the American soldiers captured Wednesday near the Kosovo-Macedonia border, the state-run Tanjug news agency reported.

The investigating judge said court proceedings had begun and that "more detailed information will be known Saturday," Tanjug said. Judge Jovica Jovanovic did not say how long the preliminary phase would last or whether the soldiers would eventually be charged.

In Belgrade, one of the country's most prominent lawyers, Toma Fila, who is not directly involved in the case, said the soldiers could be charged with "waging aggression."

Way said the county has a little more time to decide how to finance the project and because Commissioner Kenny Davis was absent, the item will using a master lease to fund the bridge be considered at the next regular meet-
