He welcomed anyone who might need help or encouragement to his ington, Colo. 80807.


He helped restore the buildings at Old Town in Burlington.

Water lawsuit won't be dismissed

LINCOLN, Neb. (AP) — The U.S. Supreme Court refused Thursday to dismiss a lawsuit in which Kansas accuses Nebraska of using too much water from the Republican River ba-

The one-sentence order means that the two states will hash the matter out in court unless the issue is settled.

Kansas filed a lawsuit in 1998, accusing Nebraska of violating a 1943 interstate compact by allowing farmers to divert more than their legal share of the river's water for private

In January, Special Master Vincent

McKusick, who was appointed by the high court to hear the case, rejected a request by Nebraska to dismiss the lawsuit. Nebraska then appealed to the high court. Nebraska has maintained that

groundwater use is not regulated by the compact, which also was signed by Colorado, because it was signed before deep-well irrigation was used in the river basin.







