It spread quickly across the U.S., and has been in Goodland for about 10 vears.

"It's really grown in the years it's been here," said Whisnant, adding that they would like more people to get involved.

"We would like to see more young families," she said, adding that young people might not participate because they don't want to wake up on Saturday morning, or feel they are too busy to do volunteer work.

cause of the deteriorating condition of the bridge.

Pickman said he does not expect the 2000 census to show Goodland's population to be over 5,000, which might make the city eligible for grant programs for the road work. He suggested the commissioners and city consider asking Amy Griffey, area economic development specialist, to meet with them to see if there are grants the city or county could get for this work.

Davis said the other option is to extend the county's special quarter-cent sales tax to cover the work, but he would not feel comfortable doing that until everything is examined.

"If we find this is the best way to do the project," he said. "I think we should place a letter in the papers explaining to the public what we are doing and why.'

Selby said the group also discussed the new landfill, and the possibility of changing to a user fee next year. She said Pickman and Lutters felt this was a good idea.

"I told them we have about a year to get this set up, and that we needed to work together so the fees can be fair,"
