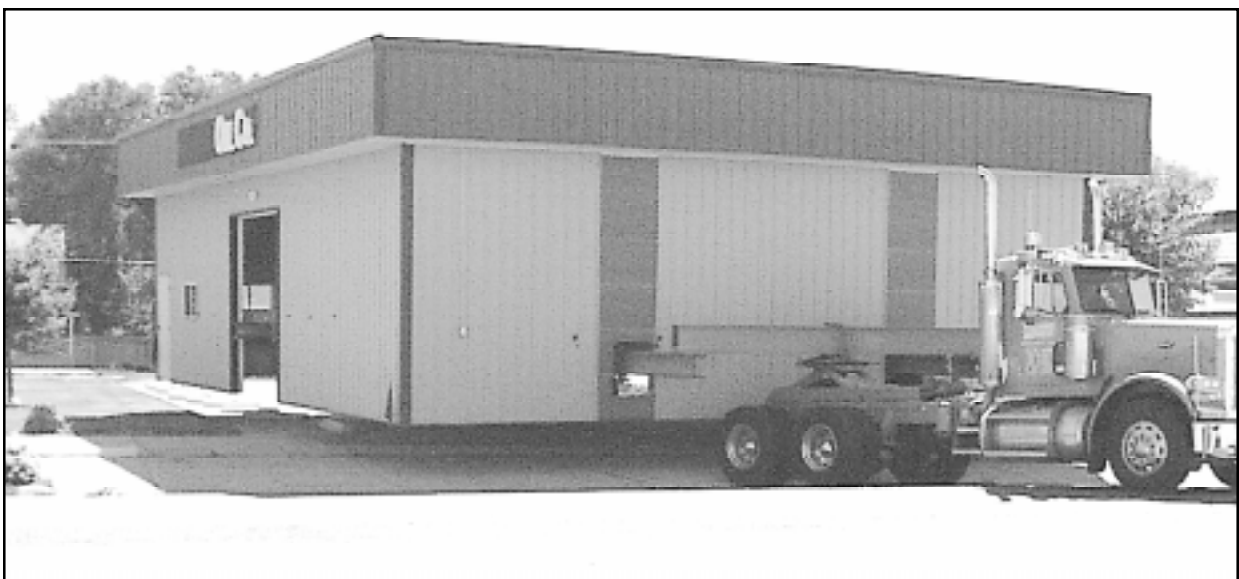

# First National Bank gets building

A metal oil building from the Amoco gas station on K-27, which is now closed, was moved to the First National Bank at 11th and Broadway on Monday.

Part of Broadway was blocked off for over an hour Monday morning while city workers and a truck driver

for Williams Midwest worked to maneuver the building onto the bank property.

Bank President Larry McCants said the building will be used to store vehicles and paper.

The bank owns property east of it where an older house sat until Tuesday.

McCants said the house was acquired by Rod Cooper, who moved it to another location, so that the space would be available for expansion.

McCants said he plans to have the basement filled in where the house sat and have sod laid over it.
