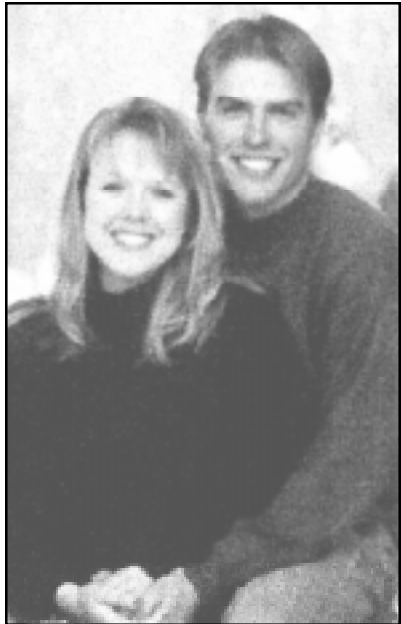
The groom-to-be’s parents are Richard and Lynn Goin of Peyton, Colo.
