**ORDINANCE NO. 1441**

**AN ORDINANCE PERTAINING TO THE FEE SCHEDULE FOR THE DISPOSAL OF SOLID WASTE AND REPEALING AND AMENDING SECTION 7-118 OF THE CODE OF THE CITY OF GOODLAND, KANSAS. BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GOODLAND, KANSAS:**

**Section 1. FEESCHEDULE.** All residential solid waste customers within the city shall be charged a base rate for the collection of solid waste collection fee of \$10.00 per month.

**Section 2.** All commercial solid waste customers within the city shall be charged a base rate for the collection of solid waste in the amount of \$12.00 per month. The base rate includes one container with one weekly collection per month. A second and all subsequent containers shall be charged at the rate of \$24.00 per month and shall include one weekly collection per container per month. All additional collections will be at the rate of \$6.00 per collection per container. The city reserves the right to add or remove containers based on the volume of solid waste generated by any commercial customer.

**Section 3.** All rural residential solid waste customers shall be charged a solid waste collection fee of \$12.00 per month per container.

**Section 4.** All rural commercial solid waste customers shall be charged a base rate for the collection of solid waste in the amount of \$22.00 per month. The base rate includes one container with one weekly collection per month. A second and all subsequent containers shall be charged at the rate of \$28.00 per month and shall include one weekly collection per container per month. All additional collections will be at the rate of \$7.00 per collection per container. The city reserves the right to add or remove containers based on the volume of solid waste generated by any rural commercial customer.

**Section 5. REPEAL.** Section 7-118 of the Code of the City of Goodland is hereby amended and repealed.

**Section 6. EFFECTIVE DATE.**

This ordinance shall take effect and be in force from and after its publication in the official city newspaper.

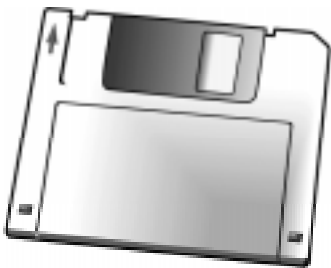
