Arthur Bruce Channell, 89, a former Goodland city councilman, died Thursday, Oct. 5, 2000, at Hays Medical Center in Hays. He was a longtime Goodland resident.

He was born April 11, 1911, in Menlo, the son of Mary M. (Houston) and Albert Joseph Channell.

He graduated in 1931 from Menlo High School.

He and Florence Irene Duffey were married Nov. 1, 1933, at Menlo. The couple lived in Menlo for 10 years before moving to Burlington, Colo. Then in 1952 they moved to Goodland.

Mr. Channell went to work for Kline’s Produce of Goodland in 1952. Later he started his own produce business. He retired at 62.

He was a member of Golden Buckle Campers Club, the Masonic Lodge and the United Methodist Church, all of Goodland; and the National Campers and Hikers Association.
