Ambush *is nightmare for fans*

The Goodland Daily News SCOTT CITY—Say it ain't so. Tell us that the Ambush in Scott City really didn't happen, that it was all just a nightmare and that we're going to wake up at the state tournament in Salina.

Please say that the No. 1 Cowgirls, season is still going on. Tell us that the lone blemish on the Cowgirls' record didn't happen at sub-state, that it happened in some parallel universe where the loss really doesn't count.

How I wish I could say it wasn't so. But I can't.

The Ambush in Scott City was a nightmare, for sure, but it was a waking one. Goodland (36-1) fell to Scott City (32-5) 15-9, 12-15, 15-12 in the sub-state finals Saturday, ending the Cowgirls' season. Goodland advanced to the finals by drawing a bye as the top seed, then defeating Ulysses (11-21) 15-8, 15-5.

The Cowgirls played as if the weight of their undefeated season and their No. 1 ranking were dragging them down. The key to beating Scott City was avoiding mistakes, forcing the Beavers to play to perfection. In their previous two meetings, Goodland had done precisely that, taking Scott City in two games each time.

But not this time. With the Goodland crowd roaring so loud that the radio broadcasters were deafened from the noise, Goodland committed numerous unforced errors. Scott City played nearly to perfection.

"Our hitters went timid and we had way too many service errors (an unheard of nine)," Goodland coach Jerry McKee said. "They hammered our blockers and we didn't hit into their blocks. We couldn't get a hold of the momentum and we couldn't get them double block to get back the serve. to shank a pass."

In the first game, Goodland led 6-3 before the team unraveled. Scott City went up 9-6, helped by Goodland errors.

The Cowgirls tied the game on three straight Scott City errors before Goodland's Ashley Hallagin had a questionable roofing call.

At first the official called Hallagin hits. an illegal back-row hitter. When Hallagin explained that she was in the Goodland's Evann Hardy and Beaver with a cross-court kill. Kasper hit the front row, though, the official changed her call to roofing. Scott City's Nicole Rogers then served.
