# **Center wants new** accessible elevator

The Goodland Daily News The Good Samaritan Center administrator talked with the Sherman County commissioners about the elevator project at the center at Thursday morning's meeting at the courthouse. Paul Rainbolt, the center's administrator, said a handicapped accessible elevator is to be built on the southeast corner of the building and that they have a bid from Glen Strait Associates of Colby on the project.

"We think we're real solid on the bid," Rainbolt said.

This project would cost \$118,000 with \$78,000 of it to come from the center and \$40,000 to be paid by the county.

Rainbolt said the center also plans to remodel the kitchen and put up a new garage this next year.

The center has allocated \$100,000 for the two projects out of its capital reserves fund.

The kitchen remodeling needs to be done to meet fire standards and to make more room in the dining room because it gets congested with walkers and wheelchairs, he said.

The project will extend into the present garage, so the center would need to put up a new garage which would be used as a receiving area and storage for lawn and snow removal equipment.

Rainbolt said he tries to keep the private pay expense for residents as low as he can, but that the center will have an average increase of \$7 in its rates as of today. The average rate for rooms per day was \$83.
