
Getting rid of the evidence

Examination planned

TOPEKA(AP)—Attorney General Carla Stovall's office will examine the planned merger of Tyson Foods and beef and pork processor IBP Inc., her chief deputy has told legislators.

However, Senior Deputy Attorney General John Campbell warned legislators that Stovall's office will need to hire three employees.

He also said the attorney general's office would need to tap \$100,000 in revenues generated from consumer protection cases to have the resources for its examination.

Campbell outlined the attorney general's plans in a letter sent Tuesday to Senate Agriculture Chairman Derek Schmidt, R-Independence, who asked Stovall to review the merger.

Schmidt and legislators from both parties generally were pleased with Stovall's plans. The Kansas Farm Bureau, the state's largest agriculture group, also praised her.

"If there ever was a role for government to pay on behalf of production agriculture, this is it," said Farm Bureau President Stan Ahlerich.
