However, if no petition or claim is filed within thirty (30) days of mailing of this Notice, your interest in the property described above will be forfeited. All such requests, petitions and claims shall comply with the strict requirements for claims as set out in K.S.A. 60-4111.

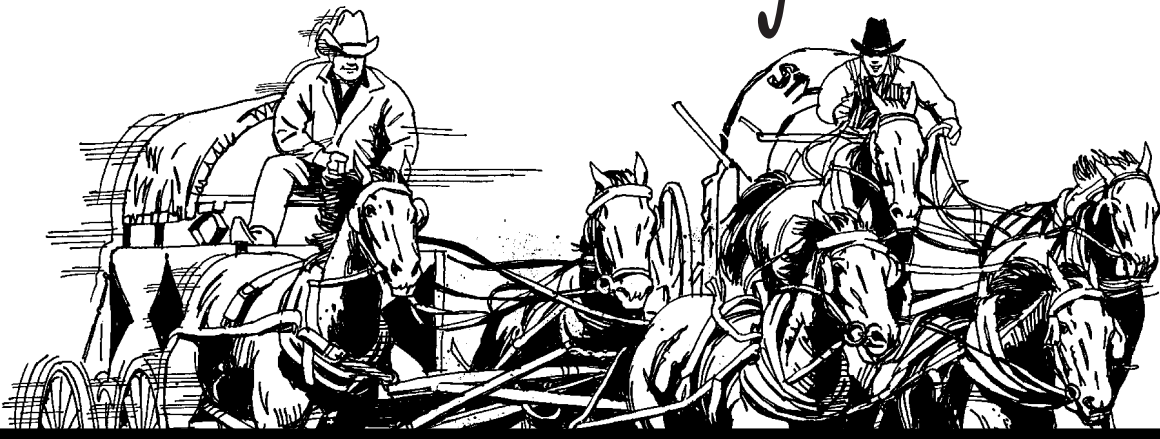
